The "Potenciar a Agricultura Sustentável" seminar, held on November 28, 2023, at Hotel Vila Galé Ópera, Lisbon, was a joint effort within the IPMWORKS project, alongside FNOP's F&H\_Org initiative. The event brought together around 60 participants from different corners of the agriculture sector.





In the first session, "Seminar F&H\_Org," David Gouveia from GPP an overview of national organisation of production, sharing insights from different sectors and geographical areas. A panel moderated by Alexandra Diogo followed sharing European insights as well as concrete examples from Producers Organisations.













After lunch, the "Seminar IPMWORKS" focused on the Sustainable Use Regulation of phytosanitary products. Bárbara Oliveira from DGAV provided insights and updates from the SUR, followed by a panel discussion moderated by João Cardoso from ANIPLA.













The day concluded with a roundtable discussion moderated by Carmo Martins from COTHN where farmers and advisors including Bruno Neves, Luís Constantino, and Rosário Antunes, shared their experiences with holistic strategies to reduce the use of phytosanitary products.
